Notes

The ASCH sends a list of registered professional members every month to participating health funds that pay their fund members for hypnotherapy. The Medibank Report is sent on the 2nd and 4th Monday of each month.

Change of details

To modify your details, please complete the [Health Fund Registration Form](#) and post or email it to the ASCH. The ASCH office will forward your change of details only to those health funds who receive our monthly updates. To remain on the registered professional members list, please ensure that your membership fees are paid, OPD and supervision requirements are met, and that you have current insurance and first aid certificate. If your insurance or first aid expires and you do not notify the office prior to the monthly listing being distributed, you will be removed from the list until the new information is received.

Rules for receipts to clients

That invoices and receipts must always:

- Include the health fund provider number, if requested by the health fund
- ASCH membership number
- Be rendered in English
- Specify the name, address and phone number of the health care provider who provided the treatment
- Specify the ABN of the health care provider
- Specify the date of treatment
- Specify the person to whom treatment was provided
- Specify the amount that was charged for the service
- Specify the type of treatment provided

Revocation of rights of qualifying member to use Association Provider Number (APN)

Each qualifying member ceases to be entitled to recognition and ceases to be entitled to use the APN:

- If his or her membership of the ASCH is suspended or ceases for any reason
- If he or she ceases to hold membership of the ASCH at the qualifying level
- If the ASCH's agreement with the health fund is terminated
- Where the health fund notifies the individual qualifying of the ASCH that the particular qualifying member's entitlement is revoked or suspended (and in the case of suspension, the cessation of recognition and of entitlement to use the APN continues until the Health Fund might, in its discretion, notifying the qualifying member or the ASCH that the suspension is ended)
